

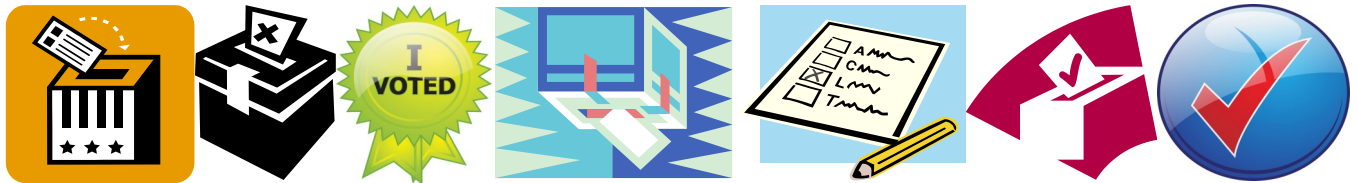

ASPRS NATIONAL ELECTIONS 2012-2013

An important responsibility of the ASPRS membership is to participate in the election of the organization's national officers. As of the date of this newsletter all current voting members should have received the ballot for the national elections. Please take a moment to review the candidates and take an active role in the operation of the organization by submitting your votes by the advertised deadline. The goal of ASPRS is to have 100% participation by the eligible voters. This year a longtime member of the SW region is standing for election as the Vice President of the National Organization. Dr. A. Stewart Walker has served as President of the SW region, as National Director representing the SW Region, and also as a Member of the National Executive Committee.



ASPRS REGIONAL ELECTIONS 2012-2103

As with the election of the national officers, there are regional chapter elections conducted in February of each year. The regional chapters represent the local interests of the membership, organize local technical meetings, social events and support the region's local student chapters. The regions provide a grass roots level opportunity to participate in ASPRS and to have direct input into the National Organization. The regions have a much smaller organizational footprint than the National Organization and receive ongoing financial and organizational support from the National organization.

The ASPRS SW Region is governed by a set of [bylaws](#) which describe the regional chapter operations. The SW Region holds elections for Vice President, (who will assume the Presidency in the following year), a National Director who represents the region at the National Board of Directors, and three Regional Directors who provide representation from the various geographic areas within a region. The responsibilities of Regional Directors include the organization and implementation of technical meetings in their geographic sub-region and support for the sub-region's student chapter and activities. This year, only the Vice President and Regional Directors are up for re-election. The National Director term expires in 2014.

FOR REGION VICE PRESIDENT (1)

DR. STEVEN J. STEINBERG



Steven J. Steinberg, PhD, GISP, has been an ASPRS member since 1993. He served two terms as Nor-Cal Region President from 2008-2011 following a term as President-Elect from 2007-2008. Prior to that he served as education chair from 2001-2004 during which time he helped to initiate the Nor-Cal Regional Scholarship and Student Chapter travel support programs.

From 1998-2011 he was a Professor of Geospatial Sciences and Director of the Institute for Spatial Analysis at California State University, Humboldt in Arcata, California. During that time he initiated and advised a successful ASPRS student chapter, chartered in 2001. In Spring 2011, he moved to the Southwest Region (Irvine, CA) where he is currently a Principal Scientist – Information Management & Analysis at the Southern California Coastal Research Project and an Adjunct Professor at Chapman University teaching GIS.

Russia Wonders if U.S. Radar Ruined Space Probe

Russia will look into the possibility that a U.S. radar station could have inadvertently interfered with the failed Mars moon probe that plummeted to Earth, Russian media reported Tuesday, but experts argued that any such claims were far-fetched.

NASA spokesman Bob Jacobs also said the U.S. space agency was not using the military radar equipment in question at the time of the Russian equipment failure, but instead was using radar in the Mojave desert in the western United States and in Puerto Rico.

Russia's state news agency RIA Novosti quoted Yury Koptev, former head of the Russian space agency Roscosmos, as saying investigators will conduct tests to check if U.S. radar emissions could have impacted the Phobos-Ground space probe, which was stuck in Earth's orbit for two months before crashing down near Chile and Brazil.



"The results of the experiment will allow us to prove or dismiss the possibility of the radar's impact," said Koptev, who is heading the government commission charged with investigating causes of the probe's failure. U.S. experts suggested that the Russians should look for causes of the failure at home.

Phobos-Ground was Russia's most expensive and the most ambitious space mission since Soviet times. Its mission to the crater-dented, potato-shaped Martian moon was to give scientists precious materials that could shed more light on the genesis of the solar system.

Russia's space chief has acknowledged the Phobos-Ground mission was ill-prepared, but said that Roscosmos had to give it the go-ahead so as not to miss the limited Earth-to-Mars launch window. (Associated Press, 2012)
