

Dear PE&RS Subscriber,

Considering the convenience of digital access and the rising costs associated with printed journals, ASPRS is making important changes to our *PE&RS* subscription model for 2023.

All 2023 subscribers will receive full digital access to *PE&RS* though Ingenta Connect for the price of a basic subscription. The hardcopy printed journal will still be available for 2023, but there will be an additional charge of \$400 US added to the basic subscription, plus shipping and handling.

We believe that the 2023 model is beneficial to subscribing institution in that they can:

- Easily access PE&RS through IngentaConnect
- Access PE&RS archives dating back to 2003
- Avoid the problem of delayed or missing issues due to international mail problems
- Request multi-site licenses for institutions with multiple campuses

In addition, we will also be waiving open-access fees for primary authors from subscribing institutions. This can represent significant cost savings to these authors and their institutions, who had to pay \$2000 per article for open access under the previous subscription model of *PE&RS* and many other OA journals. Open-access publication can benefit authors through greater visibility of their work and conformance with open science mandates of funding agencies.

We hope that your institution will take advantage of these benefits by ordering or renewing your subscription to *PE&RS* today!
