## NEWS FROM THE PRESIDENT

The second meeting of the Board of Direction for the year 1947 was held on April 7 and the usual long agenda confronted the Directors. A considerable length of time was devoted to a discussion of the best way of handling the petition, which is opposed to the present member classification articles as written in our Constitution and By-Laws. Mr. E. S. Massie presented his interim report which represents a very logical and clear analysis of the situation. It is hoped that the voting on this issue can be done by mail very soon and thereby settle this matter once and for all.

I cannot refrain from expressing my complete satisfaction with the efforts of the various committee chairmen and committeemen upon whom devolves the real work of the Society. The plea which I made at the annual meeting in January for willing workers has been answered many times over. I am so encouraged by the success of our "Every Member Get a Member" drive to date that I feel it is in the realm of possibility to double our membership this year. With this in mind, let me urge every member to do his share.

The Program Committee has been very active with regard to the Antarctic Expedition meeting. By the time this material is printed the meeting will have been held. I wish to compliment the committee on the excellence of the job which they have done. The success of the meeting is due entirely to their efforts.
