Report of the Executive Director

PRESIDENT MOFFITT, officers and members of ASP, distinguished guests, ladies and gentlemen:

I am pleased to second President Moffit's welcome to our 46th Annual Meeting, and only the second held outside Washington, D.C.

The St. Louis Convention Staff, capably headed by George Cline, has done a tremendous job and we have a large audience here today. Even the weather has been mild!

Society Administration. There seems to be one sure thing that I can report to you about the Society staff. I have a new secretary again; Sheryl Sauer. She is back in Washington watching the office.

Here in St. Louis we have Mrs. Virginia A. Bowyer, our office manager, and Mrs. Jean Engel, who handles publications and advertising billing. I also want to introduce our consultants, Mr. Hugh B. "Red" Loving, our Advertising Manager, who continued his winning ways by increasing ad revenue another 34%, and Mr. Morris M. Thompson, our Publications Consultant, who has been invaluable in handling all aspects of publications during the past year.

During 1979, we have continued to streamline our office procedures. We have managed to operate at reduced staff because of these procedural changes. Mrs. Donna Leeds, our Membership Clerk, has done an excellent job in maintaining our membership records this year.

Membership. At year-end 1979, the Society's membership was 7250, an all-time high; 6305 regular members and 945 students. This is up 28 from last year; an increase but not a very substantial one.

By contrast, Sustaining Membership at year end was 133 up 12 from 1978, with 3 more applications in process. Dues collection, now on a calendar-year basis, is going much better than in the past.

The Region membership picture is a little disappointing. Only five Regions increased in size in 1979 and of these only two met their membership goals. In 1978, 12 Regions grew in size.

We need the help of all members to encourage their colleagues to support ASP and become active.

Publications. The Handbook of Non-Topographic Photogrammetry, edited by Dr. H. S. Karara, was published during 1979.

Editor-in-Chief, Chet Slama, promises to have the 4th Edition of the *Manual of Photogrammetry* out by December. I sure hope so, because we sold the last copy of the 3rd Edition about five months ago!

We published several proceedings: Thermosense, The 7th Color Workshop, and the technical papers from the Annual and Fall Technical Meetings. Several others are in progress, including Thermosense II and Auto Carto IV.

We are having a special sale at the ASP desk, so if you haven't stopped by, I suggest that you do so.

Dr. James Case and his staff continue to make *Photogrammetric Engineering and Remote Sensing* better. We still need more practice-oriented papers, so let's hear from the private sector.

Finance. Income continues to climb. \$460,000 in 1979, up about 7 percent over 1978. However, our expenditures were \$524,000, about \$100,000 more than 1978. Our Board has approved a deficit budget, but the deficit was less than we anticipated, mainly because no money was spent on the 4th Edition.

The 1980 budget being presented to the Board tomorrow forcasts another deficit. Income is estimated at \$528,000 and expenditures at \$576,000, a deficit of \$48,000.

The officers are exploring ways to pay for the 4th Edition of the *Manual of Photogrammetry*. It's not easy to plan to spend \$130,000 on one publication, with a \$525,000 budget, but we will do it.
